## **Assistant Professor of Criminal Justice**

Department of Sociology, Anthropology, and Criminal Justice Studies Full-time, Tenure-Track Position #F0003

The Longwood University Department of Sociology, Anthropology, and Criminal Justice Studies invite applications for a tenure-track Assistant Professor to begin August 2018. The successful candidate will possess a Ph.D. in Criminal Justice, Criminology, or a closely related discipline. Applicants who are ABD with a firm defense date will be considered.

Applicants for this position must be generalists in Criminology/Criminal Justice who will teach lower level and upper division undergraduate courses. Candidates who can teach corrections and courts classes are preferred. Candidates must demonstrate an ongoing research agenda. The successful candidate will be expected to advise students and participate in departmental, college, and university service. Longwood's Criminal Justice Program has approximately 270 undergraduate majors.

Salary is commensurate with applicant's experience and qualifications. Commonwealth of Virginia benefits accompany this position. A successful criminal background check is required. Review of applications will begin October 4, 2017 and continue until the position is filled. AmeriCorps, Peace Corps, and other national service alumni are encouraged to apply.
